- (3) Several explanations are required in the additionality analysis. How is this benchmark determined? There is no source for the information.
- (4) How can 13 Euros be taken as the price of the CER? Do they have proof from a buyer willing to settle at this level?
- (5) Is the equity IRR taken? A separate analysis must be done for Karnataka and Tamil Nadu. Bundling within more than one State makes additionality very difficult to prove. On what basis is it homogenous to be taken as one bundle? Thank you for the clarification.
